REVENUE AND TAXATION CODE SECTION 69.5 ORDINANCES

Effective June 5, 2015, the following eleven counties have ordinances implementing the intercounty base year value transfer provisions of section 69.5 of the Revenue and Taxation Code for persons age 55 and over and severely and permanently disabled persons (Propositions 90 and 110):

Alameda	Orange	San Diego	Tuolumne
El Dorado	Riverside	San Mateo	Ventura
Los Angeles	San Bernardino	Santa Clara	

Since our last letter on this subject (Letter To Assessors 2014/061, dated December 4, 2014), the Tuolumne County Board of Supervisors voted on May 5, 2015, to enact a section 69.5 intercounty ordinance.
