2016 Timberland Production Zone Values

Administrative Consent Agenda – November 2015

Section 434.5 of the Revenue and Taxation Code requires that, by November 30 of each year, the Board certify to county assessors the current values of lands zoned for timberland production. Section 434.5 also specifies that the values, which vary according to defined sites within three regions, be determined based on a specified formula.

On the 2016 lien date, land zoned for timberland production shall be valued per acre according to the following schedule. These 2016 values will be mailed to the county assessors after certification by the Board.

When the assessor, pursuant to Revenue and Taxation Code section 434, designates a timberland parcel or portion thereof as inoperable, such timberland parcel, or portion thereof, shall be valued as if it is Site V.

The 2016 values have increased by \$1 - \$11 per acre (5.35%) due to a combination of low timber values dropping out of the calculations and an increase in timber values and volumes harvested over the past several years. Attached is a detailed analysis showing the calculations made to determine these values.

This item is scheduled for Board consideration on the November 17, 2015, Property Taxes Administrative Consent Calendar.
