2016-17 State Employees Food Drive Results

Out of the 94 participating state agencies, the Board of Equalization once again ranked #1 in contributions to the annual Holiday Food Drive.

Since the annual Holiday Food Drive kicked off in early November 2016, the employees of the Board of Equalization collectively donated 167,904 pounds of good – of that 116,938 pounds was donated from District Offices.

Here are some notable statistics:

- Turkey Drop Event: Collected 521 turkeys, totaling 7,133 lbs.
- Winterfest Raffle Basket Event: \$10,443 converts to 26,107 lbs.
- Silent Auction Bake Event: \$755 converts to 1,887 lbs.
- Rummage Sale Event: \$553 converts to 1,383 lbs.
- Run to Feed the Hungry Participation: \$2,320 converts to 5,800 lbs.

All Departments and District Offices were very active in collecting and donating food to either the Sacramento Food Bank & Family Services, or to their local food banks. This strong spirit created a tight competitive race to see who could raise the most food during the campaign.
