## Re: February 23, 2022 Board Meeting, Agenda Item M.2.a. Public Policy Hearing. Impact of Public Calamities on Property Tax Administration: County Boards of Equalization/Assessment Appeals Boards (AAB) Remote Hearings: Lessons Learned Presentations.

As you may recall, in the course of the testimony by Work Group participants over the past several months, the Board has received feedback regarding real time experiences from the participants. The feedback ranged from scheduling to technology driven issues.

One key technology-driven issue that has emerged related to "document submission," due not only to the deadlines, but also to the technology differences among counties. Our Letter to Assessors stated among other things that technological platforms for remote hearings should provide the ability to view evidence in real time while preventing the public from viewing trade secrets. Some counties have generously offered to report to the Board lessons learned and progress made with respect to various aspects of meeting the challenges of remote hearings in general and technological problems involved in remote hearings.

On behalf of the Executive Office of the Los Angeles County Board of Supervisors, Mr. Edward Yen, the Board's Assistant Executive Officer, will provide the Board with an informational presentation on the County's lessons learned regarding the virtual hearing system. One area of focus, which is proving to be an effective and efficient solution to the problems and nuances of "document submission" in remote AAB hearings, may be adaptable as a solution for other counties.

Item M2a 2/22/22 Representing, San Diego County is Ms. Ann Moore, Chief Deputy Clerk of the Board of Supervisors, who will present on San Diego County's lessons learned. Specifically, she will focus on San Diego County's ability to implement virtual hearings as soon as their Board of Supervisors transition to virtual meetings. She will highlight their experience and the steps they took to implement best practices, refine their virtual hearing process, and the logistical and technical best practices adopted in San Diego County.

We were extremely pleased that counties are willing to share information about their lessons learned and discuss examples of how it works to enhance the AAB remote hearings. We believe that these presentations will provide an opportunity for the Work Group participants, counties, and the Board, to understand the type of modernization systems and tools that are effective for ensuring the best virtual hearing experience for taxpayers, assessors, all witnesses, and AAB members.

We are very grateful for this opportunity and look forward to possible future discussion on how such technology and tools may be made available offered to all.
