With this in mind, I am seeking your input and careful consideration, with a request that you propose additional items for inclusion or other suggestions for the *Potential Issues Calendar* at

the October 24-25, 2023, Board meeting. I am confident that with your contributions at the meeting, we will have a final *Calendar* that we can adopt.
