## Re: <u>October 24, 2023, Board Meeting Item 5. – 2024 Board Meeting Agenda Potential</u> <u>Issues Workload Plan.</u>

Honorable Members, in proposing an agenda plan for the key issues we may want to consider in the 2024 calendar year, I am submitting a draft *Potential Issues Workload Plan* or List for your review and input today. In our discussion last month, the potential issues were embedded in a yearlong calendar that was a little difficult to work with visually, so in its place, I am proposing a simple Workload Plan absent any dates. Included in this draft are many issues we are currently working on, as well as some that Members have mentioned in prior Board meetings. In our discussion on October 24, I would like to explore whether more items should be added, or other changes should be made in this plan and would also like a recommendation from the Executive Director on Items 13 - 19.

The goal is to develop a *Potential Issues Workload Plan* that is useful both for our planning purposes, and also for more fully informing the Executive Director, enabling her to prioritize and have research and reports completed timely. As a collaborative resource tool, I think it will help all of us to focus on and eventually agendize significant matters that need the Board of Equalization's attention or constitute a worthy and important presentation of information in the open forum of our meetings.

It also serves as an effective roadmap that will enable us to prioritize and move forward the known critical issues facing us as we perceive them now but is also fluid enough to allow for real time adjustments as unanticipated issues arise. Most importantly, the *Plan* is a public document that can be posted on our website to more fully inform our stakeholders, enhancing transparency and providing more meaningful opportunities for their engagement.

With this in mind, I am seeking your input and proposals for additional items for inclusion in the *Plan* at the October 24, 2023, Board meeting.
