Free Income Tax Return Preparation at VITA Locations in Sacramento County

Sacramento – Individuals and families who need help with income tax return preparation can visit Volunteer Income Tax Assistance (VITA) locations throughout Sacramento County. These free services are sponsored by the Sacramento Coalition for Working Families and Board of Equalization Member George Runner.

“I urge eligible Californians who need tax help to take advantage of these free opportunities. Many individuals and families may be unaware that they’re eligible for hundreds, if not thousands, of dollars in tax refunds. VITA helps bring those dollars back to California to the benefit of taxpayers and our economy,” said Runner.

Individuals who are eligible can qualify for as much as \$6,044 from the [Earned Income Tax Credit](#). Taxpayers should bring proof of identification including social security cards, wage and earning statement(s) from employers, interest and dividend statements from banks, bank routing and account numbers for direct deposit, and a copy of last year’s federal and state returns if available.
