## TO COUNTY ASSESSORS:

## **TAXABLE PUBLICLY OWNED LANDS**

Section 11 of Article XIII of the State Constitution specifies a formula for use in determining assessed valuation of certain types of publicly owned lands.

In accordance with Article XIII, the factor to be used for 2026-27 assessments with respect to land assessed on the lien date in 1966 has been determined to be 138.90260. For land assessed on the lien date in 1967, it is 124.29836.

The 2025-26 assessed valuation on "land only" of \$4,205,861,609,000 was divided by the January 1, 2025, civilian population figure of 39,529,000. The resultant current land value per capita was divided by \$766 to obtain the 1966 factor and by \$856 to obtain the 1967 factor.
